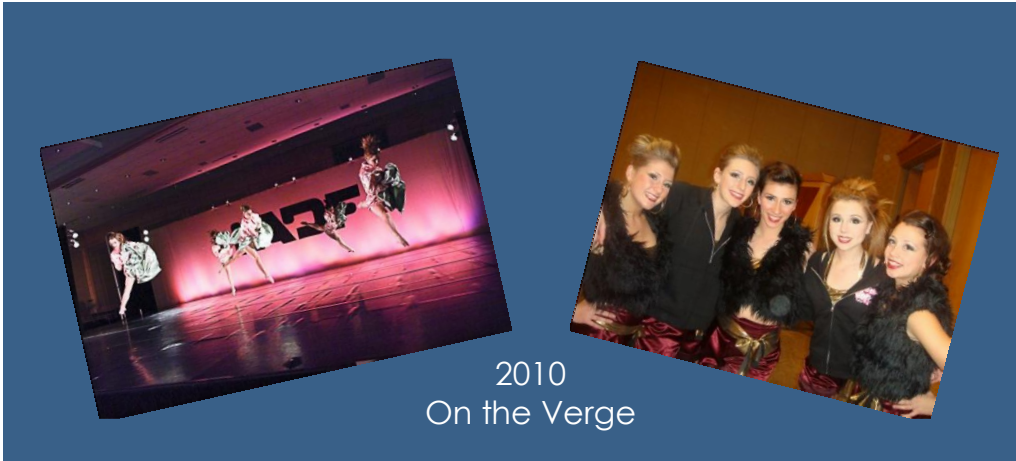

Recital Information!

Wow, the year has flown by, and the recital is quickly approaching. We wanted to go over some of the specifics:

Class and Individual Pictures will be taken on **Saturday May 1st** at the EDP studio. You should have received an email with the estimated times for your dancer's class. There is also a list on the bulletin board at the studio. **Picture DVDs** will be available to purchase at the Dress Rehearsal for **\$20.00**.

Dress Rehearsal will be held on Wednesday, May 19th at the Nampa Civic Center. We will start at **4pm** with all the **Kinderbaby/ComboKids & Pre-Company** classes (Thurs show then Friday show). All other **Thursday show** dancers must be ready at **4:30pm**. We will go straight through, start to finish, followed by the Friday show. IF your dancer is **ONLY** in the **Friday show**, please be at Nampa Civic Center no later than **6pm**.

Dance Recital is Thurs, May 20th and Friday, May 21st at the Nampa Civic Center starting promptly at **6pm**. Dancers should be ready at **5:30pm**. Please see schedule for which day your dancer will be dancing.

Seat Tickets are on sale as of April 19th at 3:30pm for the price of **\$8.00/each**. We will not be reserving seats over the phone or by email. We will need payment at time of picking up your assigned seats. It will be first come first serve! You may purchase tickets from EDP (in the office) or from Nampa Civic Center online at www.nampaciviccenter.com for \$9.00/ seat. If your dancer is in both shows,

there will be a discount. Please see Melissa for details when purchasing your tickets. To guarantee your seats, please do not delay your purchase.

Flowers will be again available for purchase each night of the recital. They will go on sale promptly at 5:15pm. You may purchase **1 for \$3.00 or 3 for \$8.00**.

A quick reminder about **Recital DVD's** – you have already paid for them! It was included in your registration fee. We will notify you **through email** when they are ready for pick up.

All costume, monthly tuition and any extra fees MUST BE PAID IN FULL prior to the dress rehearsal. If you are unsure about your account balance, please check with Melissa ASAP. We do not want any dancers not to be able to participate due to outstanding account balances!

Finally, in preparation for the 2010-11 dance year, we are asking for your help. If there are any **suggestions or requests** regarding type of class, class day or time of practice or even for a certain teacher, please write them down and place in the suggestion box in the EDP lobby. Although we may not be able to accommodate all requests, we do want to have your suggestions to help the year be more accommodating to everyone.
